## **Glen and Arlene Litfin Nature Area Archery Annual Pass Terms and Conditions:**

### **Annual Pass Rules and Regulations:**

- Visitors must have annual pass on their person, visible at all times while using the archery range and/or the archery course.
- The Annual Pass will be accepted for unlimited admission into the archery range and/or archery course during the 2024 season (ends 12/31/24) for the individual listed on the application.
- Annual Passes may not be transferred or shared with another person not listed on the application.
- If your pass is lost or stolen, please alert City Hall (763-972-0550) and we will deactivate the card. Replacement cards will cost \$2.00.
- All Annual Passes will be deactivated at the end of the 2024 season. 2025 memberships will be issued starting in January of 2025.

### **General Archery Rules: (rules also listed at the Glen and Arlene Litfin Nature Area)**

- Range and Course are unsupervised. Use at your own risk. You are legally responsible for any injuries and/or damage caused by you to another person and/or property. The City of Delano is not liable for these damages.
- Adult supervision (18+) required for children under 15 years of age.
- Arrows with field points only. Crossbows and/or broadhead arrows are prohibited.
- No firearms or alcoholic beverages allowed on the course.
- Archery course and range are only open during daylight hours
- In case of an emergency call 911.
- Report any broken targets to the CITY OF DELANO: (763) 972-0550

### **Archery Course Rules: (rules also listed at the Glen and Arlene Litfin Nature Area)**

- Make sure you stay on the marked trail.
- Everyone should follow the designated course by station numbers.
- Go throughout the course with caution. **Stay Alert!**
- All archers should remain in the staging area while waiting to shoot.
- No shooting outside of the designated shooting lanes.
- Only shoot at targets (**NOT** wildlife).
- Wait until all arrows have been shot before retrieving them down range.
- Leave bow on hanger when retrieving arrows.
- When looking for lost arrows, be prompt and do **NOT** wander far from target.
- **NEVER** shoot when others are searching for their arrows at your station, or whenever others could be in danger of being shot.

### **Archery Range Rules: (rules also listed at the Glen and Arlene Litfin Nature Area)**

- Stay within the boundaries of the range.
- Do not shoot until everyone is behind the shooting line.
- When target round is complete, all archers are required to retrieve shot arrows together.
- Before walking over the firing line, call "**CLEAR**".
- When returning from the firing line, call "**LINE IS HOT**" before starting.
- Inappropriate behavior will result in removal from the range.
- Range closes at sundown.

I understand that these risks known or unknown, anticipated or unanticipated may result in injury, death, illness, disease, or damage to myself or my property, or to other persons and their property.
- In consideration of being allowed to use and participate in this Activity, I hereby personally assume all risks in connection with this Activity and I hereby agree to hold the City, its officials, employees, agents and contractors harmless and I waive any right to make claims or bring lawsuits against the City or anyone working on behalf of the City for any injuries or damages related to the alleged negligence of the City.
- This waiver does not apply to any injuries or damages that are the result of any willful, wanton, or intentional misconduct by the City or anyone acting on behalf of the City.
- I understand that entering into and signing this agreement affects my legal rights and results in my giving up or waiving certain legal rights, and I accept and sign this agreement of my own free will.
- The terms of this agreement shall bind the members of my family, if I am alive, and my heirs, assigns and personal representatives if I am deceased.
