**PEDDLER | SOLICITOR | TRANSIENT MERCHANT

All permits are approved administratively after the completion of a background check. **All applicants must apply in person and present a photo identification.**

**DEFINITIONS:**

**PEDDLER.** Any person, whether a resident of the City or not, who goes from house to house, from place to place, or from street to street, conveying or transporting goods, wares, or merchandise or offering or exposing the same for sale, or making sales where payment is received immediately for future delivery to purchasers. It does not include vendors of milk, bakery products, or groceries who distribute their products to regular customers on established routes.

**SOLICITOR.** Any person, whether a resident of the City or not, who goes from house to house, place to place, or from street to street with the intention of taking immediate orders for services or goods

for future delivery and payment. All solicitors dealing with merchandise of any kind to be delivered to customers directly from points outside the State shall be exempt from payment of the license fee.

**TRANSIENT MERCHANT.** Any person, firm individual, corporation, limited liability company, and corporation, both as principal and agent, who engage in, do, or transact any temporary and transient selling and delivering of goods, wares and merchandise within the City, and who, in furtherance of such purpose, hires, leases, uses, or occupies any building, structure, motor vehicle, trailer, tent, railroad car, boat, public room in hotels, lodging houses, apartments, shops, or any street, alley, or other place within the City, for the exhibition and sale of such goods, wares and merchandise, either privately or at public auction, provided that such definition does not include any person, firm, or corporation who, while occupying such a temporary location, does not sell from stock, but exhibits samples or the purpose of securing orders for future delivery only.
