ORDINANCE O-14-09

ORDINANCE ANNEXING LAND LOCATED IN FRANKLIN TOWNSHIP, WRIGHT COUNTY, MINNESOTA PURSUANT TO MINNESOTA STATUTES 414.033 SUBDIVISION 2(1) PERMITTING ANNEXATION BY ORDINANCE.

THE CITY COUNCIL OF DELANO ORDAINS:

Section 1. The City of Delano is the owner in fee simple of land legally described on Exhibit A and depicted on Exhibit B (the "Property").

Section 2. The Property abuts the City of Delano and is deemed to be urban or suburban in character or about to become so.

Section 3. The Property is appropriate for annexation to the City of Delano pursuant to Minnesota Statute 414.033, Subd. 2(1).

Section 4. Pursuant to Minnesota Statutes 414.033, no public hearing on the proposed annexation is required.

Section 5. The Property is hereby annexed to the City of Delano.


Section 6. Because no taxable property is being annexed, no reimbursement to Franklin Township is required under Minnesota Statutes 414.036.

Section 7. The City Clerk shall file this Ordinance with the Chief Administrative Law Judge of the State of Minnesota, Franklin Township, the Wright County Auditor, and the Secretary of State.

Section 8. This Annexation Ordinance shall be final on the date the Ordinance is approved by the Chief Administrative Law Judge of the State of Minnesota.

Section 9. This Ordinance shall be published in accordance with law.



Location of Property to be Annexed






 Delano City Limits
