**ORDINANCE NO. 0-11-03 2011**

**AN ORDINANCE AMENDING CHAPTER 4 BY ADDING ARTICLE 416.05 RELATING TO PLUMBING PERMITS, PLANS AND SPECIFICATION REVIEW, AND INSPECTIONS OF PLUMBING SYSTEMS; AND ADOPTING BY REFERENCE CITY CODE CHAPTER 1 AND SECTION 105.01, WHICH AMONG OTHER THINGS, CONTAINS PENALTY PROVISIONS.**

**THE CITY COUNCIL OF THE CITY OF DELANO, MINNESOTA ORDAINS:**

**SECTION 1.** City Code Chapter 4 is hereby amended by adding Section 416.05 to provide as follows:

**SECTION 416.05. Plumbing Regulations**

**Subd. 1. Authority to Inspect:** The City of Delano hereby provides for plumbing permits, approval of plumbing plans and specifications, and inspections of plumbing, pursuant to Minn. Stat. §326B.44.

**Subd. 2. Adopted by reference:** Minnesota Statutes Chapter 326B, Sections 326B.41 to 326B.49 and Minnesota Rules Chapter 4715 ("Plumbing Code") are hereby incorporated into this ordinance as if fully set out herein. All such codes incorporated hereby by reference are adopted pursuant to Minn. Stat. §471.62 as the plumbing code of the City of Delano.

**Subd. 3. Compliance.** All plumbing systems, plans and specifications shall comply with the requirements of the plumbing code of the City of Delano and this ordinance.

**Subd. 4. Insurance.** Pursuant to Minn. Stat. §326B.44, no person who engages in the business of plumbing in the City of Delano need post a bond or maintain public liability insurance as a prerequisite for engaging in the business of plumbing, except the bond to the state and insurance required under Minn. Stat. §326B.46 and except any performance bond and insurance required under a contract with the person for the performance of plumbing work for the City.

**Subd. 5. Permits and Fees.** Any inspection or permit fees will be payable to the City of Delano.


**Subd. 6. Violations and penalties.** A violation of the plumbing code of the City of Delano is a misdemeanor and will be reported to the Minnesota Department of Labor and Industry. (M.S. 326B.082, Subd. 16).

**Subd. 7. Sunset.** This ordinance shall be revoked without further action of the City Council once the Department of Labor and Industry is funded for the 2011 fiscal year by legislative enactment of a state budget.

**SECTION 2: Purpose**

The purpose of this amendment is to establish a program for plumbing permits, approval of plans and specifications, and to authorize inspections required by the plumbing code in the City of Delano that is administered and enforced by the City.

**SECTION 3:** This ordinance is effective immediately upon its passage and publication.
