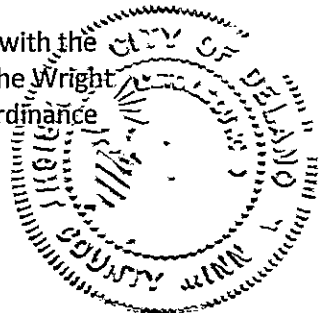

**Ordinance O-20-11**

**An Ordinance annexing certain property abutting the City of Delano**

- Section 1.** The City of Delano has received a petition for annexation by ordinance from all the property owners of the annexation property, George Fake Revocable Land Trust of the land described on Exhibit A (the "Property").
- Section 2.** The Property abuts the City of Delano, is 59.77 acres in area less than the 120 acres for annexation by ordinance; and is not presently served by public sewer facilities or public sewer facilities are not otherwise available.
- Section 3.** The property lies within the planned Extraterritorial Land Use Plan of the Delano 2030 Comprehensive Plan which guides this are for annexation and low density urban residential land use.
- Section 4.** The City has planned and constructed city streets and utility infrastructure to the property boundaries. The City utility infrastructure has the size and capacity to accommodate the annexation property.
- Section 5.** The City of Delano has held a public hearing on Tuesday, December 15, 2020, regarding annexation of the Property and given 30 days written notice of the public hearing by certified mail to Franklin Township and to all landowners within and contiguous to the Property.
- Section 6.** The Property is appropriate for annexation to the City of Delano pursuant to Minnesota Statutes 414.033, subd. 2 (3).
- Section 7.** The Property is hereby annexed to the City of Delano.
- Section 8.** Property taxes payable for the Property shall continue to be paid to Franklin Township for the year in which this annexation becomes effective. If this annexation becomes effective on or before August 1, 2021, the City of Delano shall levy on the Property beginning in 2021. If this annexation becomes effective after August 1, 2021, the City of Delano shall levy on the Property beginning in 2022.
- Section 9.** The City of Delano shall reimburse Franklin Township an amount equal to the Township's share of 2020 property tax for two years (\$277.38), all outstanding Township assessments levied against the annexation property (\$187.00) and any debt that the Township incurred prior to annexation attributed to the annexation parcel. The city shall make two equal payments over the two years following the annexation approval.
- Section 10.** The City Clerk/Administrative Services Coordinator shall file this Ordinance with the State of Minnesota, Office of Administrative Hearings; Franklin Township; the Wright County Auditor; and the Minnesota Secretary of State, and a copy of this Ordinance shall be delivered immediately to the Wright County Auditor.



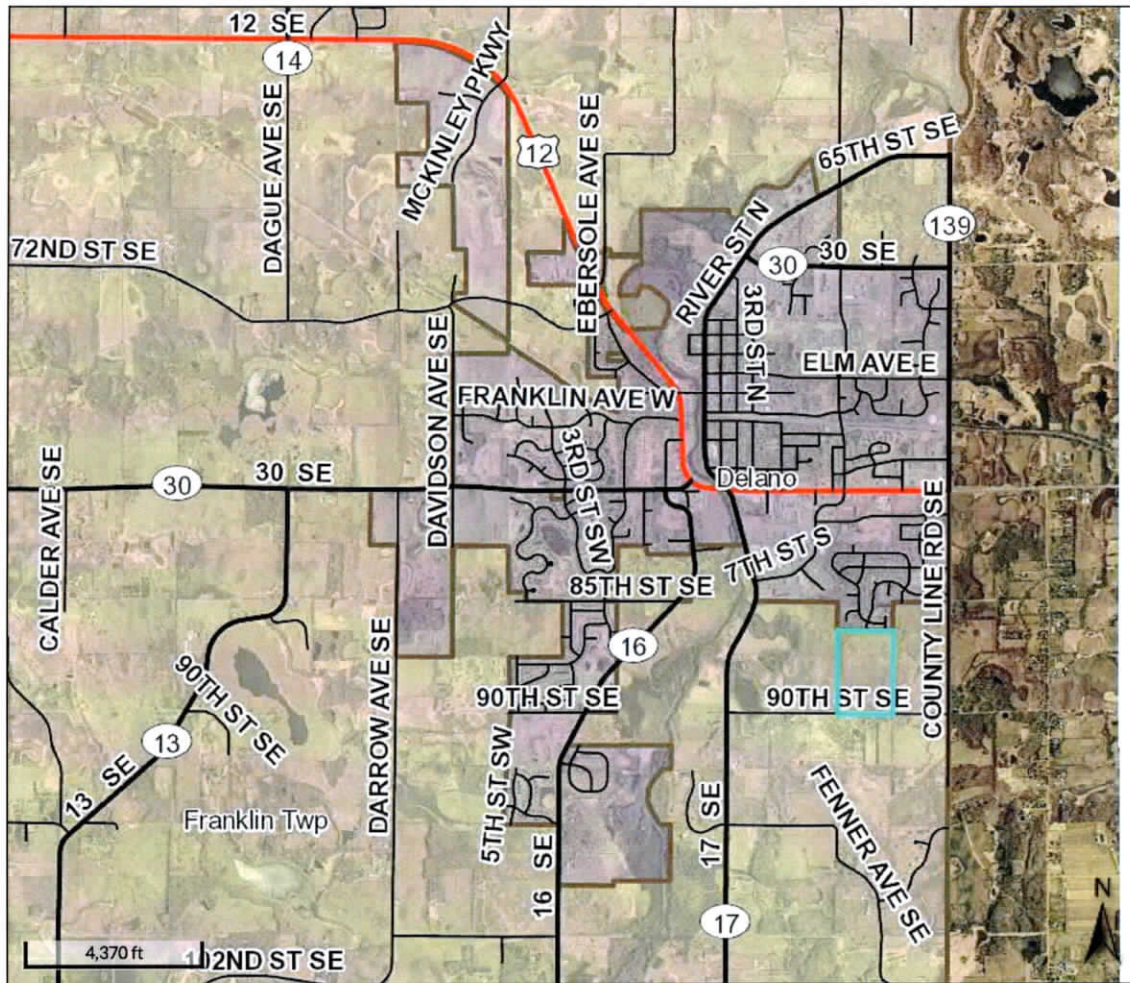

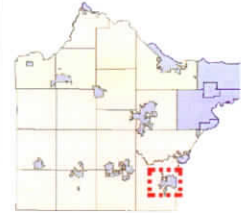
Legal Description of the Real Property:
