This diagram (drawn to scale or with dimensions included) must show the point at which the fireworks/pyrotechnic special effects are to be discharged; highways, streets, communication lines and other possible overhead obstructions; and the lines behind which the audience will be restrained. For proximate audience (i.e. indoor) displays, the diagram must also show the fallout radius for each pyrotechnic device used during the display.
4. Names and ages of all assistants that will be participating in the sale or public display.
