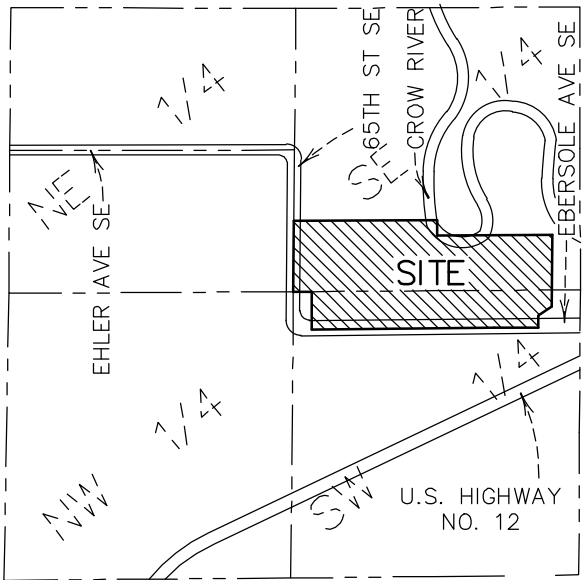

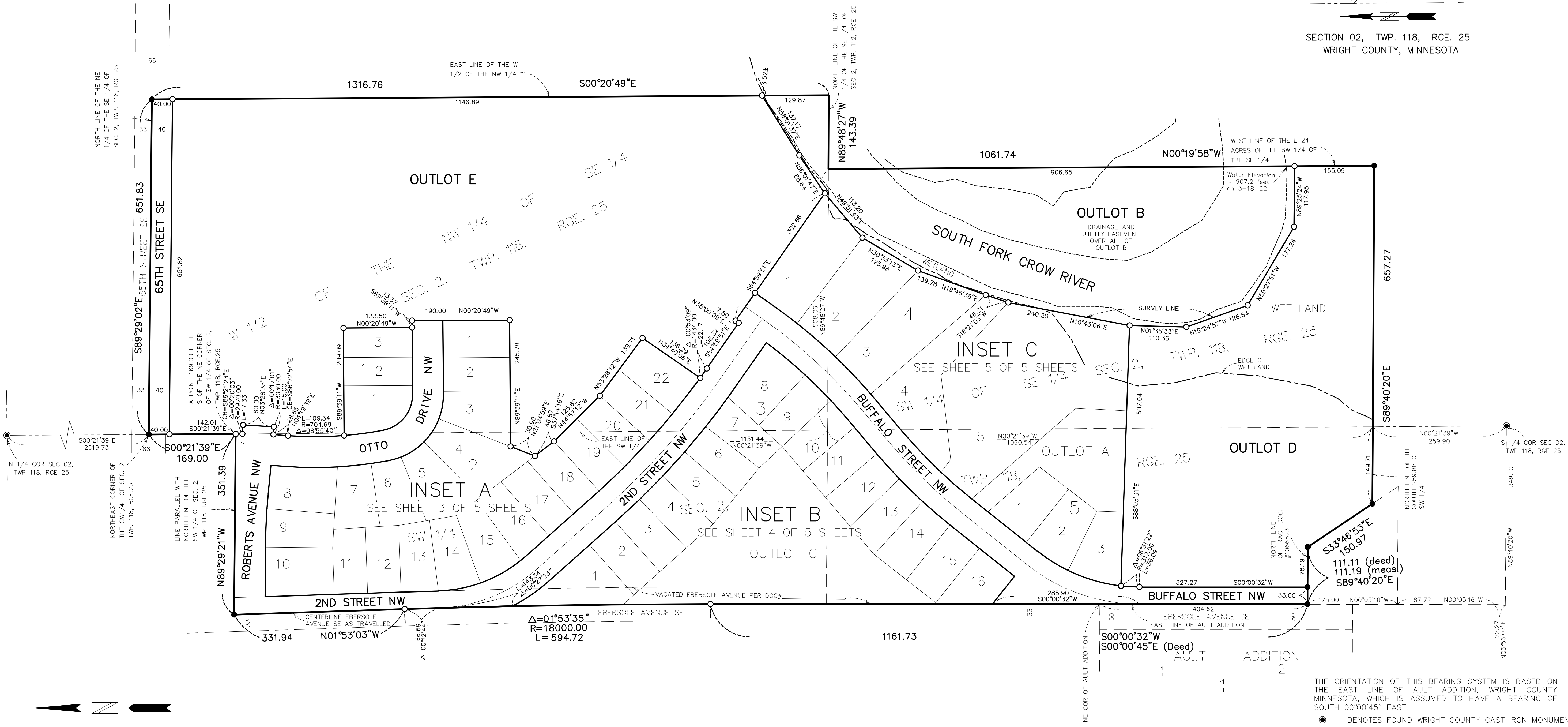

WRIGHT COUNTY, MINNESOTA



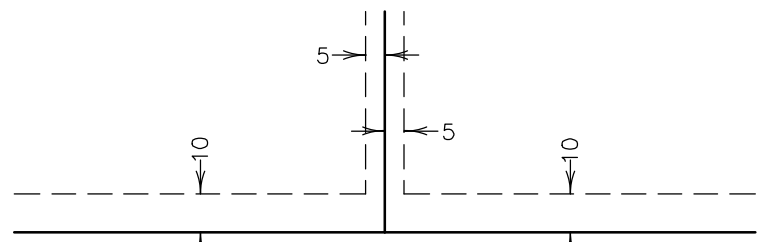

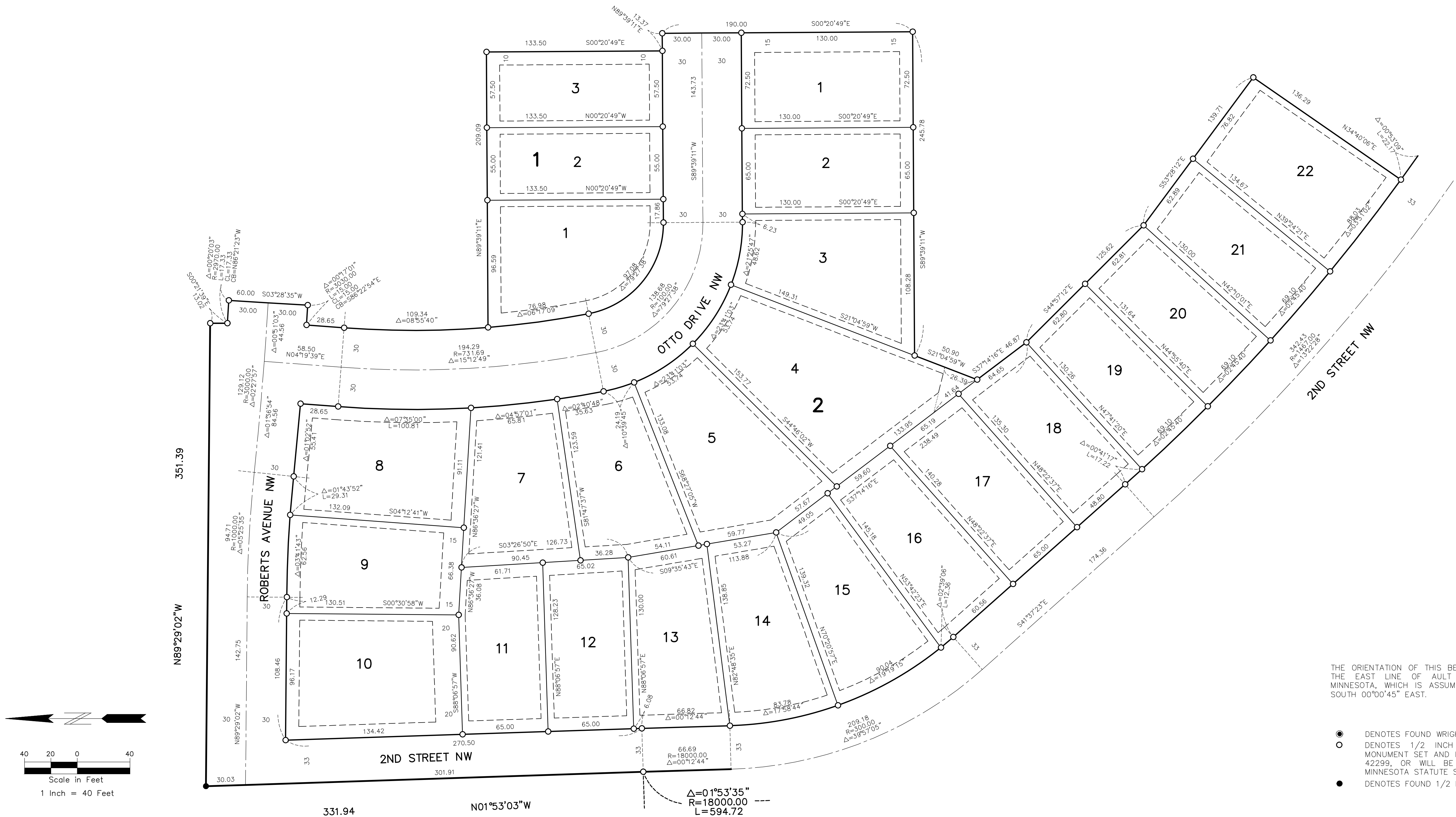

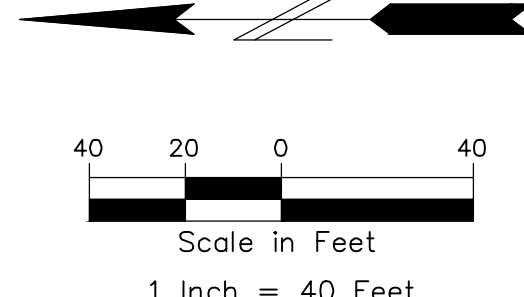
