Spirit Park Terms and Conditions:

Season Pass Rules and Regulations:

- The Season Pass will be accepted for unlimited admission into Spirit Park during the season for the individuals listed on the application.
- Season Passes may not be transferred or shared with another person not listed on the application.
- Season Passes will be deactivated at the end of each season.

General Spirit Park Rules:

- No outside food or beverages
- No smoking, alcohol, tobacco, cannabis, illegal drugs, or weapons.
- No loitering or horseplay.
- No blades are to be worn outside of designated areas.
- No hockey games, sticks, or pucks on the pleasure rinks outside of designated hours.
- Children ages 10 and younger must be accompanied by a chaperone.
- Please follow Rink Staff instructions.
- In the event of an emergency and a parent/guardian is not readily available, staff will use the contact information listed on Page 1 of this document.
- The City of Delano is not responsible for lost or stolen items.

Hours:

- Season Pass holders may use the facility only during public ice rink hours, which will be posted at the entrance to Spirit Park and on the City's website. Every effort will be made to honor the posted ice rink hours, but hours are subject to change throughout the season.
- Ice season will generally be October 1 – March 31, weather dependent.
- Spirit Park will close if any of the following conditions occur:
 - The temperature is -10 degrees or lower or the wind chill is -20 or lower. Staff will use discretion.
 - A Severe Winter Weather Watch or Warning is issued for the Delano area.
- If Spirit Park is closed, the City will post closure information on its website and social media accounts.

Waiver of Liability:

- I agree to allow the individuals listed on Page 1 of this document to participate in all activities at the City of Delano – Spirit Park. I agree to abide by all posted rules and regulations.
- My use of and participation in activities at Spirit Park (hereinafter referred to as this "Activity") is voluntary and no one is forcing me to participate. I acknowledge that this Activity is NOT an ESSENTIAL service provided by the City of Delano (the "City").
- I understand and acknowledge that this Activity has certain risks, including but not limited to personal injury. I understand that these risks known or unknown, anticipated or unanticipated may result in injury, death, illness, disease, or damage to myself or my property, or to other persons and their property.
- In consideration of being allowed to use and participate in this Activity, I hereby personally assume all risks in connection with this Activity and I hereby agree to hold the City, its officials, employees, agents and contractors harmless and I waive any right to make claims or bring lawsuits against the City or anyone working on behalf of the City for any injuries or damages related to the alleged negligence of the City.
- This waiver does not apply to any injuries or damages that are the result of any willful, wanton, or intentional misconduct by the City or anyone acting on behalf of the City.
- I understand that entering into and signing this agreement affects my legal rights and results in my giving up or waiving certain legal rights, and I accept and sign this agreement of my own free will.
- The terms of this agreement shall bind the members of my family, if I am alive, and my heirs, assigns and

personal representatives if I am deceased.

Season Pass, Day Pass, and Private Event FAQ

Who has to be included on a waiver?

Any visitor who interacts with the ice must have a Season Pass Application & Waiver on file with the City.

Who has to pay for a Day Pass?

Any visitor who interacts with the ice at the Spirit Park must pay the Day Pass fee. Chaperones who are at Spirit Park to only oversee children do not need to pay for a Day Pass.
