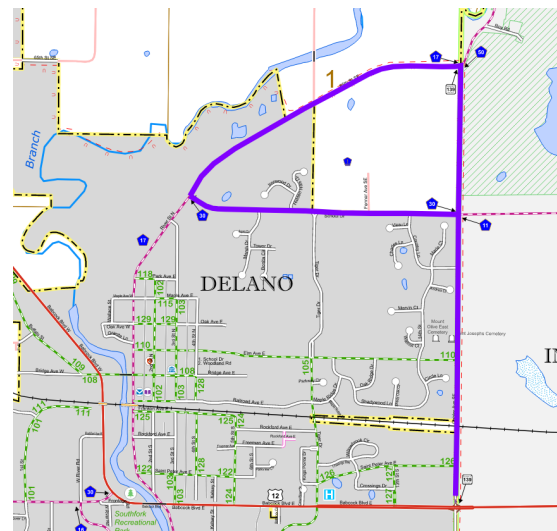

### Background

Wright County is planning a pavement preservation project on CSAH 30, CSAH 17, and CR 139 in 2026 in accordance with their 5-year construction plan as shown in the attached document and adjacent clip. The project is identified as the reconditioning of these roads, which generally consists of milling and repaving the top layer of pavement. CSAH 30 and CSAH 17 are on the County's State Aid system, and the MnDOT State Aid office is now requiring approval from the local municipalities if the project lies within their municipal boundary.



The resolution is a show of support, allows City staff to collaborate with the County, and does not have a financial impact. The County's plans are currently under State Aid review and are expected to be published for bids in the coming weeks. Staff do not have a schedule for the improvements yet but would anticipate it once the project gets awarded. Staff is recommending adoption of the attached resolution.

Resolution Supporting the Wright County Pavement Preservation Project on CSAH 30, CSAH 17 and CR 139.

**Whereas**, the City of Delano recognizes that a safe and well-maintained transportation network is vital to the economic health and safety of the community; and

**Whereas**, CSAH 30, CSAH 17 and CR 139 located within the corporate limits of the City, are County Highways under the jurisdiction of Wright County; and

**Whereas**, the Wright County Highway Department has identified a need for pavement preservation to extend the service life of the roadway and improve the driving surface; and

**Whereas**, the City of Delano desires to cooperate with Wright County to ensure the successful completion of this project with minimal disruption to local residents and businesses; and

**Whereas**, the City Council finds that this project aligns with the City's long-term infrastructure goals and enhances the overall safety for motorists, cyclists, and pedestrians.

**Therefore, Be it resolved:**

1. **Support for Project:** The City of Delano hereby formally expresses its full support for the 2026 Pavement Preservation Project on CSAH 30, CSAH 17 and CR 139 as proposed by Wright County.
2. **Collaboration:** City staff are authorized to coordinate with County officials regarding traffic control, public notifications, and any necessary local permitting to facilitate a seamless workflow.
3. **Future Maintenance:** The City acknowledges that this resolution does not alter existing maintenance agreements or jurisdictional boundaries unless specifically outlined in a separate Agreement.
4. **Effective Date:** This resolution shall become effective immediately upon its passage and approval.

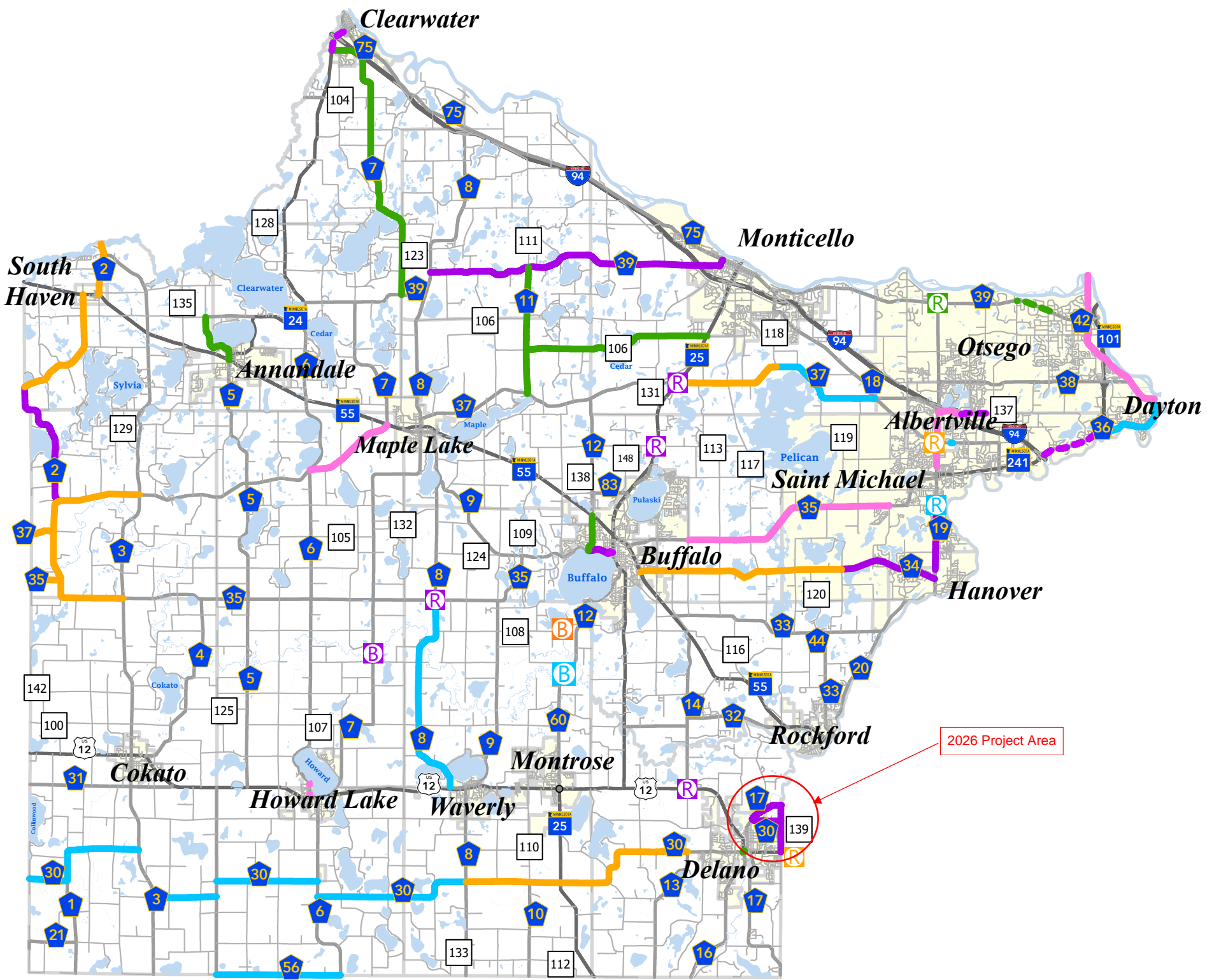
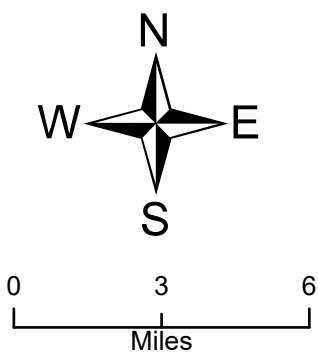
